This application is to review your eligibility for in-state tuition for the upcoming term. You may not request Virginia domiciliary status retroactively or for previous terms. The appeal should be submitted two weeks before the beginning of the semester. **Domicile cannot be changed based on materials turned in after the first day of class.** Answer all questions completely and accurately.

**Self Sufficient Student**-If you are 24 years old and/or financially independent by the first day of the next semester, you must complete the Student Appeal Form and provide documentation in your name based on your domicile.

**Dependent Student**- If you are under 24 years old and unmarried or are financially dependent on your parents/legal guardians or spouse by the first day of the next semester, you must complete the Student Appeal Form **and** your parent, legal guardian or supporting spouse must complete the Parent/Legal Guardian or Supporting Spouse Form. Provide documentation based on person(s) who claim you.

**Documentation to be returned to Admissions and Records Office\*** (check documents attached to your appeal)

- Copy of Current federal income tax return
- Copy of current state income tax return
- Copy of Virginia driver's license
- Copy of Virginia voter's registration card
- Copy of Virginia motor vehicle registration
- Document to verify date you first moved to Virginia (i.e. apartment lease/house closing statement, official employment verification)
- Military Records (if applicable)
- Documentation of Social or Economic relationships in area (volunteer records, memberships, affiliations, sources of financial support)
- Any additional documents that would objectively support claim to VA domicile
- Visa or DACA approval (if applicable, must be unexpired)

\*Providing documentation listed is not a guarantee of eligibility for in-state tuition rates. A matriculating student who has entered BRCC as an out-of-state student shall be required to refute by clear and convincing evidence the presumption that he/she is in the Commonwealth of Virginia for the purpose of attending school.

The completed form(s) and supporting documentation will be reviewed in compliance with Section 23-7.4 of the Code of Virginia to determine your eligibility. A copy of the Code and the State regulations can be viewed at <http://www.brcc.edu/admissions/residency/>. Incomplete information and/or inadequate documentation will cause delays in processing and may negatively affect the College's decision.

Section 2.12 of the SCHEV Guidelines states that in cases where a student has knowingly provided erroneous information, the College may change the student's status retroactively to the term for which the fraudulent application was filed, bill for the tuition differential, and take action for dismissal.
