Important Information about Loans

- We must have a 2018-2019 FAFSA on file before we can process this request or the application on the reverse side of this page.
- **First-time borrowers must complete the Master Promissory Note and Entrance Counseling on the [Federal Student Loan Website](#).** More information on this process may be found on our financial aid page [here](#). This step is not necessary for most borrowers who have completed an Entrance Counseling and Master Promissory Note in the past 10 years.
- Loan amount borrowed will be reduced by up to 2% in loan origination fees.
- Summer loans will be disbursed in 2 disbursements, the first of which will be at the normal time for financial aid disbursement and the second of which will be after the semester midpoint.
- Loans for new students and those who have earned fewer than 30 credits: dependent students may request **per year** up to \$5500 and independent students up to \$9500, up to \$3500 of which may be subsidized. If this annual maximum has been reached, additional loans are not available until the following academic year.
- Loans for students who have earned at least 30 credits: dependent students may request **per year** up to \$6500 and independent students up to \$10500, up to \$4500 of which may be subsidized. If this annual maximum has been reached, additional loans are not available until the following academic year.
- Submission of request form **does not** guarantee loan eligibility **nor** does it guarantee that eligible students will receive the full amount.
