Definitions

Major medical emergency - An extended illness or major medical emergency occurring during the semester in which you are registered which requires hospitalization, is life-threatening, or is contagious and is a danger to the remainder of the college community.

• Documentation will be by a physician's statement on the doctor's official letterhead (copies of the student's medical records will not be accepted). This must be an unscheduled medical emergency diagnosed after the last day to drop for tuition refund

- The physician's letter must include the date the student was first seen for the medical condition, as well as the beginning and ending date the student was incapacitated or hospitalized and must state that the student was physically unable to attend classes during this period of time (which caused the student to miss 20 percent or more of the scheduled instruction).
- A letter that does not specifically state, "the student was physically unable to attend classes" will not be grounds to approve an appeal.
- Pre-existing conditions are not justifiable.

Extreme financial hardship – involving the sudden, unforeseen loss of an extreme nature. An example of such an extreme hardship would be that caused by the loss of the student's owned home through fire or flood.

Death of a student's immediate family member - with certification. A student's immediate family is defined as father, mother, spouse, sibling, or your child.

Administrative errors by BRCC personnel. The appeal for refund in these instances must be initiated through, and with the concurrence of, the BRCC employee providing you the advice and counsel.

A student ordered to active duty (for reservists) or be mobilized (active military) as described in Code of Virginia, Section § 23.1-904
