IMPORTANT FINANCIAL AID INFORMATION FOR SUMMER 2025

- Once you have registered for your 2025 Summer classes and your financial aid application is received, your financial aid eligibility will be determined.
- Your award is based on the amount of credits that you are registered for. If you make changes to your schedule by adding or dropping classes please submit an updated application for review. Please be aware we may not be able to increase your aid after the initial application has been reviewed. If you do not notify us of any changes in your enrollment status, your award will be adjusted accordingly at the end of the add/drop period.
- ➤ Once your financial aid eligibility has been determined, you can view your summer aid award information by logging in to your MYBRCC portal and accessing your SIS account. Once in SIS you will click on My Student Information and then view my financial aid, making sure to choose the 2025 aid year.
- ▶ It is important that you make sure your award is enough to cover the tuition and fees owed to BRCC. Please log in to your MYBRCC portal, click on SIS, My Student Information, and then account inquiry. Make sure you click on the yellow bar at the bottom of the screen to see your financial aid based on your enrollment. If your financial aid is NOT enough to cover your charges owed you will need to make payment for the amount not covered. To avoid any of your courses being dropped payment will need to be made by the appropriate payment deadlines found here.
- ➢ If you are not meeting satisfactory academic progress (SAP) standards after Spring 2025 grades are posted you will be notified and will have the option to go through the appeal process. If your appeal isn't received by the deadline or your appeal is denied, your financial aid will be cancelled. You will be notified of your responsibility to pay your tuition charges or your classes will be dropped.
- ➤ If you fail to begin attendance in any course, you will be dropped from that course for not attending. Your award will be adjusted to reflect actual course attendance. If you withdraw from or stop attending any of your courses during the semester you may be required to repay financial aid for those courses. To avoid financial responsibility, you must drop any courses you don't plan to attend by the applicable last day to drop with a refund dates found here.
- If you lose eligibility for the aid you are awarded or fail to abide by the terms and conditions to receive the awards, you agree to pay the tuition in full upon notice from the College.
